A variety of considerations will be made, including financial need, before a scholarship is awarded. YES! Fund for Kids, Inc. has complete discretion regarding scholarship awards. Scholarships will be awarded without regard to the student’s race, color, sex, handicap, familial status or national origin.

Financial Information:

Financial information is required by the School Tuition Organization to report data in an aggregate format for all scholarship recipients to the State of Arizona in its annual report effective January 1, 2011 per A.R.S. 43-1089. Financial information is required for tuition scholarship assistance and will be used to verify financial need for the disbursement of scholarships. This information will be held in strictest confidence.
